1. Recommend: The Board approve Memorandum of Understanding #7 with CEA for the 2018-21 negotiated CEA agreement.

This Memorandum of Understanding ("MOU") is entered into by and between the Crestview Local School District Board of Education ("Board") and the Crestview Education Association ("Association"), collectively known as "the Parties," on this 14th day of October 2020 in order to address certain matters between them.

**WHEREAS** the Board and the Association are parties to a collective bargaining agreement for the period of September 1, 2018 through August 31, 2021 ("Master Agreement"); and

The Crestview Local Schools understand that our goal is to survive a pandemic. Our teachers go far beyond the call of duty. Now that we have begun the year, the most precious commodity is time. CEA is doing a tremendous job teaching in person and remotely. This is a very stressful time. Our goal this year is to survive and to reduce stress so that we can focus on life together to expand the minds of our youth.

- Administration agrees to "Remote Fridays" when we are designated yellow and orange and scheduled to be in school.
- All Fridays will be remote beginning 9/25/2020 for the remainder of semester #1. The exception is days that already are designated as days off. (October 9, November 27, December 25, January 1)
- The group will meet after Christmas break and review progress and determine a path for the second semester.
- This plan takes effect beginning Friday, September 25, 2020 and runs through the conclusion of the first semester of the 2020 - 2021 school year.
